**MEMBERSHIP & POWER CART RENTAL AGREEMENT**

Membership Agreement: By applying for this membership I/we hereby agree to comply with the rules and regulations of the Red Hawk Golf Club. I/we recognize that the membership rights are non-refundable once paid and apply to the regular season of April to the end of October and only to open and league play. They do not include outings or tournaments that may take place from time to time and there may be times when Red Hawk Golf Club is closed to open play because of these events or weather. I understand I am required to check in before every round and sign for any house charges.

House Charges: I understand I may take advantage of the convenience of a house charge account and agree to pay my bill by the end of the month following billing. If my account is not paid by the end of the month following billing I understand that a 1.5% finance charge will be added to my account. If house charge account is unpaid after 60 days I understand my backup credit card will be charged.

Power Cart Rental Agreement: The undersigned in consideration of use of a motorized golf cart agree:  
To return the golf cart immediately following the specified number of holes of play on the course.  
To pay for any damages to the golf cart while being used resulting from any cause other than ordinary wear, including attorney’s fee, incurred by RED HAWK in collecting any amounts owing hereunder.  
The undersigned hereby agrees and authorizes that any charges for damages under item 2 above will be charged to his/her credit card.  
To drive slowly and use caution due to varying terrain (slopes and hills) and/or conditions, and to never operate the golf cart while in neutral. The undersigned(s) represent that he/she is familiar with the safe operation, use and control of the golf cart and that he/she will abide by any and all signs, warnings, and instructions, posted or verbal by Red Hawk staff members.  
To not allow unauthorized person who have not signed this agreement or anyone under age 16 without a valid driver’s to operate the golf cart.

**Release-Assumption of Risk and Indemnity Agreement:** The undersigned appreciating the dangers of golf, the terrain (hills and slopes of the golf course) and the dangers of golf cart crash and overturn agree(s) for myself, my heirs and assigns to assume the inherent and extraordinary risks involved with golf and golf cart operation. I expressly assume the risk of and accept full responsibility for any and all injuries (including death) and accidents that may occur and release RED HAWK, all shareholders, members and staff from liability. I waive any claim I may hereafter have as a result of any injury to my person or property. I agree to indemnify and hold harmless the above named for any and all claims, including attorney fee and costs, which may be brought by anyone claiming to have been injured as a result of any injury to me or my property. I have read and fully understand this agreement. I am of lawful age and legally competent to make this agreement.
